National Consumer Law Center

NCLC just concluded its annual **National Consumer Rights Litigation Conference**, which took place last week in Boston. More than **1,000 attorneys** participated, including 107 attorneys from Massachusetts, 399 legal services attorneys from around the country, and more than 60 Assistant Attorneys General from 42 States, including Massachusetts.

In addition to dozens of workshops, presenters included the newest Federal Reserve Governor, Sarah Bloom Raskin, whose speech generated significant national coverage; Senator Sheldon Whitehouse, who gave a rousing speech articulating the needs of our clients as well as can be done; and Tom Perez, the new and passionate head of the Civil Rights Division of the US

Department of Justice.

The conference was preceded by an all-day funders meeting focusing on "The Disparate Impact of the Mortgage and Foreclosure Crisis on Communities of Color," organized by the Open Society Institute, the Annie B. Casey Foundation, the Hyams Foundation, and NCLC.
